5/8" x .040" (16 x 1.) expanded flattened aluminum bird screen in removable frame. Screen adds approximately 1/2" (13) to louver depth.

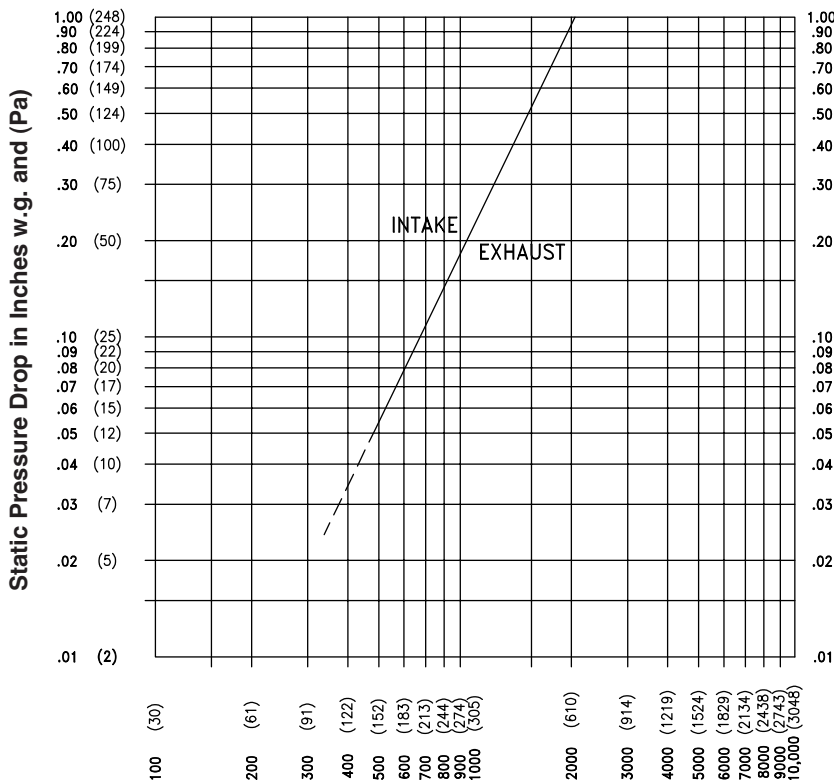

PRESSURE DROP DATA



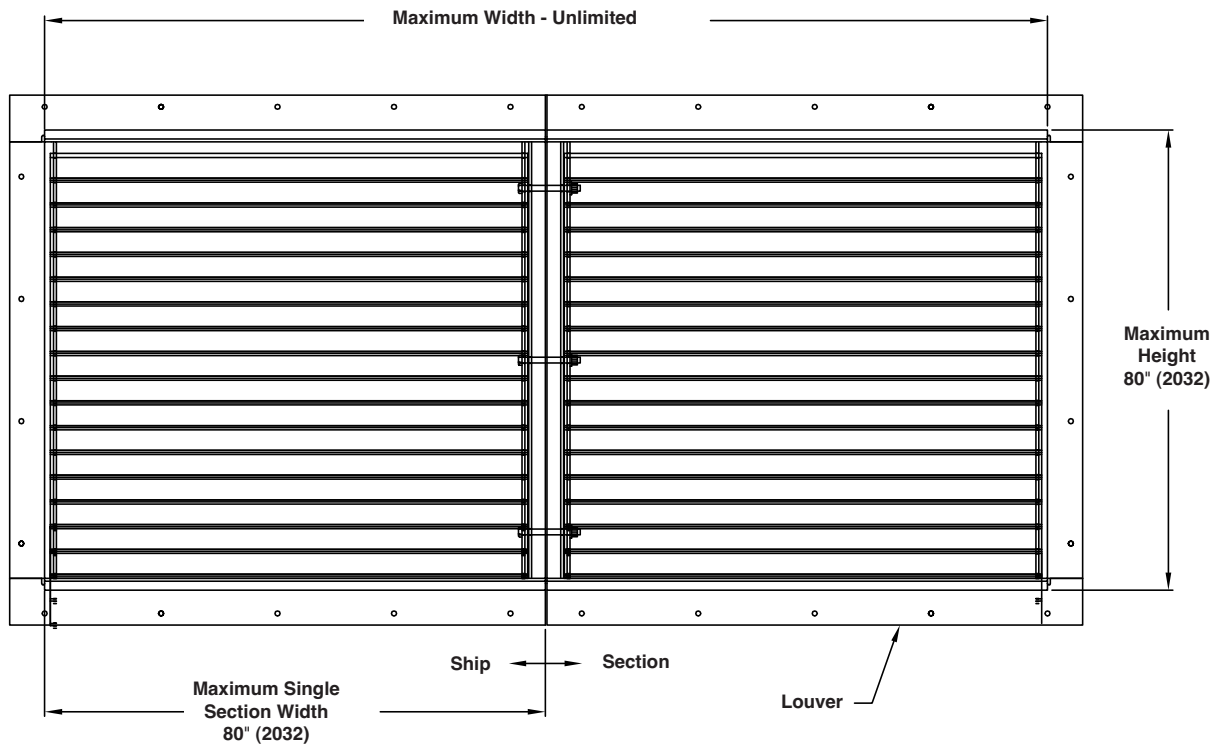
